Important Questions	Answers	Why This Matters:
What is the overall <u>deductible</u>?	In-Network: EE Only \$2,000; EE+ Family \$4,000. Out-of-Network: EE Only \$2,000; EE+ Family \$4,000.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your <u>deductible</u>?	Yes. <u>Preventive care</u> is covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost sharing</u> and before you meet your <u>deductible</u> . Out-of-Network: EE Only \$4,000 (\$1,000 additional limit for out-of-network hospital expenses); EE+ Family \$8,000 (\$2,000 additional limit for out-of-network hospital expenses).	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services.
